Item(s) 5: Roy Garner

Roy Garner, member of the Red Oak Area Historic Preservation Society, spoke with the board about the Red Oak Tractor Show now known as the Red Oak Classic. They are partnering with the Red Oak Rotary Club to host events throughout the weekend of the event. Mr. Garner wanted to request a Beer and Wine Garden within a designated area to allow participants to purchase and drink responsibly. Mr. Garner thanked the board for allowing him to speak. After lengthy discussion a motion was made to approve the Beer and Wine Garden for the Red Oak Classic by Commissioner Briley and seconded by Commissioner Bennett. **Motion carried (3-1).**

Item(s) 6: Nash County Sherriff's Office Deputy Representative

Nash County Sheriff's Office Deputy Ben Blount spoke to the board about the roadblocks that were done in Red Oak earlier this year. They were able to get many illegal items off the roads during the roadblocks. Deputy Blount went on to explain that speeding during the known times (meaning drivers are aware of the certain patrol days) is down and under control but wanting to switch up the days to make sure it is all under control. Deputy Blount said that checkpoints need to happen more often and that he wants the Town to invest in FLOCK Cameras that will also help the Office with any incidents that have occurred. Commissioner Briley also said that the pay for the Deputies needed to be increased to reflect their hard work they do in the Town. Commissioner New agreed. DFO Russ explained that it already had been budgeted in the FY 24-25 budget and would begin July 1st, 2024.

Item(s) 7: Thank you from ROAHPS

Mayor Langley had the board read the letter to themselves and expressed gratitude for their thank you letter.

Item(s) 8: LEO Contract Statistic Report

The Board reviewed the report with brief discussion.

Other: Clerk Parker explained to the board that flowers have yet to be planted at the welcome signs and that the routine maintenance of the signs was in a waiting stage due to the fear of killing the plants if maintained and they are placed.
