Old Business:

Item(s) 1: Town of Red Oak Christmas Festival Recap

Town Clerk Averi Parker stated that she has heard nothing but good things so far. The parade was full and those attending enjoyed it despite the cold weather.

New Business:

Item(s) 1: Public Input (Limit 3 Minutes Each)

Randolph Lewis, no address provided, stated that he has lived on his property for nearly thirty (30) years and has not been notified of any rezonings near his home. He understood that if there is a rezoning that he would be notified. He also stated that as the Town grows, an additional solid waste site needs to be considered.

Zoning Administrator Jackie Johnson explained to Mr. Lewis that at this time there are no active rezonings near his property and if that were to change, he would receive information as well as others nearby.

Item(s) 2: Red Oak Elementary School PTO Request

Mayor Levell Langley presented the request. The Parent-Teacher Organization was requesting funds for an upcoming class field trip. Mayor Langley asked DFO Russ how did the Town budget for the PTO's request. DFO Russ explained that the line item in the budget was not grade specific, but they would receive it all and it is up to them to split it up or use on this trip entirely. He also would like quarterly reports on the service. Commissioner New also wanted to see if the building that holds the bathroom could be repainted. Clerk Parker stated that she would reach out to Nash County Parks and Recreation for servicing, the quarterly reports and about the building.
